TUITION and FEES 2018-2019

Kindergarten – 8th Grade

- 1 Child in K-8 \$5,100
- 2 Children K-8 \$9,000
- 3 Children K-8 \$12,100
- 4 Children K-8 \$14,400

Preschool

- Two-year-olds \$1,475 (2 days/week - 2 hours/day) Tuesdays & Thursdays
- Three-year-olds \$2,050 (3 days/week - 2 ½ hours/day) Mondays, Wednesdays & Fridays
- Four-year-olds \$3,475 (5 days/week - 2 ½ hours/day)
- *There is no discount given for paying in full for preschool.*

Fees Included with FACTS Tuition Plans (Pay-In Full, Semi-Annual and Monthly).

Netbook Fee (5th -8th): \$250 per student. To be included with FACTS tuition payments.

Non-Tuition Fees/FACTS Incidental Billing Plan(15th AND the 30th of the month, September through June).

All non-tuition fees will be paid through the FACTS Incidental Billing Program- MANDATORY 2018-2019

All other non-tuition fees will be paid through FACTS as they incur with payments starting on September 30, 2018 and ending on June 30, 2019. *FACTS will send a confirmation email when any charges are added to your account.*

Mandatory Raffle Ticket Obligation: *(a separate handout is available explaining our Fair Share Program)*

This fee is NOT included in tuition and fees. All raffle money is turned in directly to St. Jude School. The maximum raffle ticket obligation is 60 tickets per family.

\$400 – 1 Student (K-8 th)	(40 raffle tickets)	\$600– 3 or more Students (K-8 th)	(60 raffle tickets)
\$500 – 2 Students (K-8 th)	(50 raffle tickets)	\$100– for each Preschool student	(10 raffle tickets)

- **Please note:** A registration fee of \$100 per family is due in January of each year for the following school year.
- This fee is a non-refundable fee (it is applied toward the following year's tuition). There is also a one-time, non-refundable processing fee of \$50 for new families (due with the registration fee in January).

Early Withdrawal Fee:

After September 1st, any student who withdraws from St. Jude School will forfeit \$300 in addition to any tuition that has been incurred up to the date of withdrawal. This fee covers books and materials.

FACTS TUITION 2018-2019

- FACTS tuition plans are MANDATORY for ALL school families. NO EXCEPTIONS.
- NO ANNUAL FEE to use FACTS.
- Credit Card, NSF and Peace of Mind Fees are the responsibility of the school family.
- Tuition Dates:

Pay-in Full	August 1, 2018
Semi-Annual	July (5 th or 20 th) and January (5 th or 20 th)
Monthly	July (5 th or 20 th) to May (5 th or 20 th) (A total of 11 payments)

ST. JUDE/FACTS INCIDENTAL FEES: NEW FOR 2018-2019 (NON-TUITION FEES)

In addition to tuition accounts, all school families will be required to pay for non-tuition fees with FACTS.

- FACTS will collect ALL non-tuition fees for St. Jude School. Examples include; extended care, hot lunch, milk, graduation, field trips, sacraments and Parents Club Fee.
- Non-Tuition Payment dates with FACTS are on the 15th and 30th of each month. (September through June).
- A separate bank account or credit card can be set up to pay for these fees.
- You will receive an email from FACTS when monthly charges are added to your account.
- MANDATORY for ALL school families.

For those already enrolled in FACTS, you do not have to make any changes. All of your plan terms and financial information will carry over for the new school year. If you would like to use a different account to pay for non-tuition fees or if you would like to make any other changes to your FACTS account, please log into your FACTS account for your 2018-2019 pending agreement at www.factsmgmt.com or contact FACTS at (866)441-4637.

For those not currently enrolled in FACTS, please set up a FACTS account at this time using www.factsmgmt.com and follow the steps to set up a new account. You will be required to enter your demographic information, financial information and set up your terms (payments in full, semi-annual or monthly payments) for your tuition account. Once your information is received and processed by FACTS, you will receive a confirmation notice via email, which confirms your

payment plan information. Please review it carefully for accuracy. Contact FACTS or St. Jude with any discrepancies. **FACTS ACCOUNT MUST BE OPENED BY JUNE 1, 2018.**

REMINDERS

July 2018	FACTS semi-annual and monthly tuition plans start.
August 1, 2018	All pay-in-full tuition payments are paid through FACTS.
September 17, 2018	FACTS non-tuition fee plan starts. (September – June).
